March 2nd is the final date for introduction of bills without suspension of Rules in the Maryland General Assembly. With just over a month remaining in the 441st session, March is a busy month with committee report and crossover deadlines quickly approaching. As of this writing, nearly 2,700 bills have been introduced, and as always, many have a potential effect on how we do business in Allegany County and the State. Arguably, the two biggest issues facing the General Assembly are SB1000 Blueprint for Maryland's Future – Implementation (Kirwan) and how “we” are going to pay for it. While there are a number of bills proposing fee and tax increases/additions or eliminating incentives and credits, we finally got our answer to the latter. HB1628 Sales and Use Tax – Rate Reduction and Services has been introduced. While the bill proposes a decrease in the sales tax rate from 6% to 5%, it proposes expanding sales tax to apply to a broad array of services currently not subject to sales tax. This action would increase sales tax revenue for the State by an estimated \$2.6 billion or roughly 50%. Proposed tax increases such as this will hit every consumer and will raise the cost of doing business in Maryland, again. Education and workforce development are a priority but there has to be a better way.

CUMBERLAND CHORAL SOCIETY is an amateur group of approximately 60 singers who meet on a weekly basis to rehearse and perform the world's great choral repertoire. They come together "for the purpose of performing and promoting the historical and current literature of choral music, including classical and related sacred and popular forms."

The Cumberland Choral Society, beginning its 80th Season in September 2020, comes together to sing all genres of music from classical to pop and Broadway. Judith Brown is the current Artistic Director and has been directing the group since September 2010. Past directors include Alfred Mudrich, George Ott, Craig Schultz and Karen Sarnaker. Their members include people from all walks of life including doctors, professors, teachers, lawyers, clergy, accountants, actors, former music majors. In short, people who love to sing. They rehearse diligently over many weeks and see this process as a journey towards expressing their best efforts to honor the composers' intentions. They perform with as many instruments as their budget allows, presenting their works as complete with choral and instrumental balance. They have presented the complete exhilarating story of Elijah by Felix Mendelssohn to an arrangement of Jingle Bells by Barbra Streisand to a gospel arrangement by Rollo Dilworth.

They give two main concerts every year, a Holiday concert in December, given two times, and a Spring concert, also given twice. They also travelled to the Highland Arts unlimited series in Keyser this past December as well as performed some of their Holiday selections at Life Fitness in LaVale and the Allegany Arts Council open houses. Interest in belonging to CCS has remained constant, averaging between 45 to 60 singers. They ask anyone interested in joining to come for a short simple audition consisting of singing a simple song, matching pitch, ear testing and finding out about past choral experience.

The group is funded totally by donor support, ticket proceeds and partial grants from the Halmos Community Fund through the Community Trust Foundation and Allegany Arts Council. Ticket proceeds make up for only a small fraction of our overall cost.

In this world of division and partisanship music is a force that can unite us. It can cross all barriers and divisions. The vibrations created when we make music can physically alter our physical and emotional outlook. And when that music-making is in a GROUP setting such as a choral group, the benefit is exponentially greater than the individual

part. A successful performance produces a "high" and joy that nothing else can match.


