Business owners take calculated risks based on the information, market conditions and rules available to them at the time. They develop business and marketing plans, acquire a business location, purchase equipment and supplies, hire employees, deliver a product or service and make decisions according to the laws handed down to them by our elected representatives. Whenever any of the conditions change, it causes uncertainty and is a time to reevaluate and adjust. This is especially evident during election years and when legislators are in session.

The events surrounding the COVID-19 outbreak are like a hundred legislative sessions rolled into one and then worse. There is little process for public input, no committee hearings and relatively no advance notice. Typically when laws are changed we at least have a few months or even years to plan and make adjustments to comply with new regulations. Not today. Change how you do business this week. to melt in a few days or even a week and things instantly go back to normal. Is it going to be maybe a few weeks, months or even years? We can’t control the hysteria but we can control how we react to it. One thing for sure is, though, throwing our hands up and doing nothing

is not an option. We need to make business happen today and plan, prepare and execute the gradual reopening. Some parts of the economy will recover sooner than others and there will be a spike of increased production soon but some impact will last for a much longer time. There is a heightened need for information, accurate information. The burden will likely fall on employers to comply with the rules for reopening. There is accurate reliable information out there and now is the time to rely on fellow Chamber members for help and support.

There is no playbook for this. We are all learning and adjusting at the same time. While it is an overused cliché, we are all in this together. Yes, it does mean we are all experiencing the same frustrations and you are not alone but it also means we all have a role to play in the recovery. As the Maryland Strong: Roadmap to Recovery is rolled out, we need to help each other by sharing best practices and support local businesses. We need to make an effort to direct people to official information provided by our local, state and federal governments, not rumor or speculation. We need to be patient and understand that everyone is dealing with something none of us has ever experienced. Understand also that the economy needs to get moving again, though safely, as quickly as possible. We need to embrace the new normal and support our local economy. We all have a choice to make it happen, watch it happen or just wonder what happened.

Member Profile: Toasted Goat Winery at Hotel Gunter

Toasted Goat's Tasting Room, Tap Room, and Restaurant are located in the Historic Hotel Gunter in the middle of the growing Arts and Entertainment District of Frostburg Maryland. Hotel Gunter has been a shining gem in Frostburg since it opened in 1897 and it remains so today.

The Hotel Gunter has had a rich history since its early days. It boasted 100 rooms, a barbershop and a cafe, along with tennis courts and a petting farm complete with a tame fawn. A fifth-floor observation deck offered majestic views of the town of Frostburg and the surrounding Allegheny Mountains.

The hotel offered even more intrigue during the early 20th century. Because federal agents were transporting prisoners from the Midwest to Washington, DC, Gunter built a jail cell in the basement. While not in use, the cell is still part of the hotel.

During Prohibition, one could find politicians and others local dignitaries at the speakeasy that doubled as a cockfighting arena.

Purchased by Donny and Kristan Carter in 2018, the Hotel Gunter is home to more than just hotel rooms. While the hotel offers 12 overnight rooms, it is also home to Toasted Goat Winery and Restaurant,

Gladstone Mercantile and most recently, Rt. 40 Distilling. Plans for a brewery are in the works.

Enjoy a delicious lunch, dinner or Sunday brunch or stop in for a glass or two of Toasted Goat's wines or Rt. 40's variety of distilled alcohol or locally crafted beers. It's the perfect place for weddings, parties, reunions and other special events. Or take some time and browse through Gladstone Mercantile stocked with clothing representing Maryland, Frostburg and, of course, Toasted Goat and Hotel Gunter; Toasted Goat Wines, a variety of Maryland products alcohols; and locally produced merchandise. History, style, and service are always in good taste at Hotel Gunter. 

Leadership Allegany! Alumni Committee Update

To date, 82 individuals have accessed over \$32,000.00 from the scholarship fund from the first Class of 1998 through the current Class of 2020. 16% of the **Leadership Allegany!** alumni have been given an otherwise unavailable opportunity to learn about our region, develop their leadership skills, and make a positive impact in our county and communities through the Scholarship Fund. The scholarship fund covers up to 50% of the tuition. We hope you will consider contributing to the scholarship fund as we continue to provide educational and leadership opportunities to all members of our region.

We extend special thanks to members of the Alumni Association for their contributions, time, and energy in keeping the **Leadership Allegany!** experience alive and for building opportunities for other leaders.


